



PROGRAM UPDATE: 1-1-19
In addition to the FLEX part numbers, both incentive options now include US and Mexico Reman part numbers TA (RDS) (Reman dealer stock) and all Canadian Reman part numbers

2019 Eaton FLEX, TA (RDS) and Canadian Reman Incentives for the US, Canada and Mexico

Effective only for Eaton ship-direct purchases after registration from 1-1-2019 through 12-31-2019

Eaton is pleased to announce two new FLEX, TA (RDS) and Canadian Reman transmission incentive options for 2019:

1. **A growth incentive** that pays quarterly rebates to your business via Eaton Parts Certificates. Parts Certificates can be used to reduce your payables to your OEM or channel partner – they are used just like cash. The value of the parts certificates increase as you purchase more FLEX, TA (RDS) and Canadian Reman units throughout the year, starting with your 10th qualifying Reman unit purchase. Direct-ship purchases only (PDC shipments do not qualify – except Mexico).

MENU ITEM #1 - FLEX, TA (RDS) and Canadian Reman ONLY	
Incentive #1: FLEX, TA (RDS) and Canadian Reman Growth Incentive	Incentive value per unit in this range
10-19 Reman units	\$250 per units on units #10 through 19
20-49 Reman units	\$350 per each unit on units #20 through 49
50+ Reman units	\$450 per each unit starting with unit number 50

2. **A stocking incentive** that provides 1 no-charge FLEX, TA (RDS) or Canadian Reman transmission for every 10 qualifying Reman transmissions that your location purchases over the course of the year. Capped at 200 units (up to 20 no-charge). Direct-ship purchases only (PDC shipments do not qualify – except Mexico).

MENU ITEM #2 - FLEX, TA (RDS) and Canadian Reman ONLY	
Incentive #2: FLEX, TA (RDS) and Canadian Reman 10+1 Incentive	<i>Up to 200 units purchased (20-no-charge)</i> Buy 10 Factory Reman units during the course of the year (per location / dealer code), get 1 no-charge FLEX, TA (RDS) or Canadian Reman unit. No-charge unit may be a 13 or 18-Speed only if a minimum of 8 of the 10 units purchased are 13 or 18-Speed

- Once you've registered your location / dealer code, all FLEX, TA (RDS) and Canadian Reman purchases will begin to qualify for the incentive you sign your location / dealer code up for.
- To obtain your incentive, a proof of purchase form is required.

FLEX, (TA) RDS and Canadian Reman Incentive Program Details:

1. OEM Dealers and Independents in the USA, Canada and Mexico may participate.
 - a. Registration for each ship-to location (including dealer code if applicable) is required.
 - b. After registering, all orders of FLEX, TA (RDS) and Canadian Reman will count toward incentive #1 or incentive #2.
 - c. Orders prior to registration will not count toward incentives, unless authorized by Eaton.
 - d. Only Eaton direct-ship units qualify (PDC shipments to dealer / independents do not qualify – except for Mexico)
2. Proof of purchase form is required in order to obtain incentive.
 - a. Proof of purchase must include commercial invoice or bill of lading from OEM, CCC or HME.
 - b. Commercial invoices other than OEM, CCC or HME cannot be used. Dealer/ independent invoices do not qualify.
3. Customers may participate in incentive #1 or incentive #2. Incentives #1 and #2 may not be combined, or with any other Eaton program or promotion, unless authorized in writing by Eaton.
4. All purchases must be shipped complete in calendar year 2019 in order to qualify.
5. Proof of purchases must be submitted no later than January 30th, 2020 in order to qualify.
6. FLEX, TA (RDS) or Canadian Reman purchases for incentive #1 will count for each ship-to location or dealer group.
7. FLEX, TA (RDS) or Canadian Reman purchases for incentive #2 will count for each ship-to location (1 dealer code) only.
8. Rebates for incentive #1 will be paid on a quarterly basis, within 30-days after the close of each quarter.
9. No-charge units for incentive #2 will be shipped within 30-days of receipt of OEM invoice.
10. Any disputes of incentives or no-charge units will be decided at the discretion of Eaton.
11. FLEX Reman participating part numbers for the US, Mexico and Canada are shown below. RDS (Reman dealer stock) units will have an “RDS” in the suffix of the TA part number, while all standard Canadian Reman units will have a “C” in the suffix of the part number:
